# 4. Breed:

- Red Book (Susanne Petersen): since Susanne does not participate in this meeting, this agenda item will be moved to a next meeting.
- According to annual traditions, Jochen collected the <u>international statistics</u> of the registered foals.
- <u>The international database</u>, which we hope so much, will not be available for the time being. The Norwegian government considers this a European problem and forces us to look for European funds. We regret this situation. After all, this is also about the possibilities of Norwegian breeders for a national Norwegian breed.
- <u>inbreeding</u>: There is great diversity in the way the different studbooks deal with inbreeding. We cannot deal with this in a regulatory manner, but we can deal with it in an informative way. Following up on the already published article, Jan will write a sequel with possible tools that can support studbooks in dealing with inbreeding.

### 5. Events:

- <u>The live stream</u> of the stallion show was experienced as very positive by everyone. The quality was surprisingly high. We kind of dream that Norway would make a habit of this. This means that people who cannot attend this stallion show can follow him from "closeby" and also in deferred form.
